**RULES FOR ADMISSION IN UNDER-GRADUATE AND POST-GRADUATE COURSES**

**I General**  
**(For U.G. Honours & P.G. Courses)**

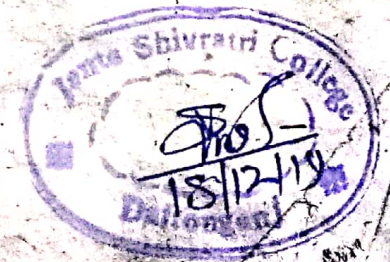
1. (a) 85% seats in all undergraduate and post-graduate including degree and diploma courses shall be filled up from, amongst the students belonging to the territorial jurisdiction of Nilamber-Pitamber University.
- (b) Selection for the remaining 15% seats be made, open for all i.e. Nilamber-Pitamber University as well as other Universities students on the basis of merit.

These seats shall also be filled up by the students belonging to all categories.

For admission in any cases of U.G. and P.G. courses under Nilamber-Pitamber University Department / Constituent Colleges / Affiliated Colleges, the Admission-in-charge / Principal / H.O.D. must see that 50% of the seats are filled up by open merit (i.e. irrespective of sex / caste etc. or even students belonging to SC/ST/OBC may compete under this category because of their merit and the rest 50% of the seats are to be filled up exclusively by the students belonging to the reservation category.

Thus the name of students seeking admission should first be arranged in order of merit. The first 50% name of the sanctioned number of seats be admitted irrespective of caste / community. In the rest 50% of the seats the following % of reservation be followed -

The criteria for admission under the heads shall be the minimum




as at the last lower examination. A separate panel for ST / SC and students based on merit shall be prepared separately. In case some seats remained unfilled by any of these above three categories (ST/SC/OBC) of students the vacant seats shall be filled up in the following manner :-

- a) Against the vacant seats of SC, the ST candidates be admitted.
  - b) Against the vacant seats of ST, the SC candidates, if available be admitted.
  - c) If no candidates of SC & ST are available for admission, the vacant seats be filled-up by the students belonging to OBC in addition to their quota.
  - d) If the specified reservation quota for SC/ST and OBC remain unfilled, the admission of General category students be made in order of merit.
2. A weightage of 10% marks shall be given to the employees / wards of husband & wife / dependent own brother and sisters) subject to the conditions that it should not exceed 10% of the total seats.
3. A weightage of 5% in total marks obtained at the last examination shall be given to all the girl students (except in women's Colleges) including those who belong to different reservation categories however, the benefit on account of such a weightage in marks shall be restricted to 50% of the total sanctioned seats N.C.C. cadets holding "C" certificate be given weightage of 5% marks over the marks obtained at their respective examination and 3% weightage on "B" certificate in matter of admission in the Degree P.G. and Law courses.
4. The Scouts and Guides recipient of Rashtrapati Award shall be given weightage of 5% marks on total marks obtained in the last examination.

A weightage of 2% marks shall be given to trained 1<sup>st</sup> class third stage of Jharkhand State Institute of Scouts & Guide.

5. Admission Rules for under-graduate courses will be followed for admission to Intermediate classes also in colleges under Nilamber-Pitamber University.

## II Under Graduate Courses

2. In addition to the above 3% of seats may be allotted for outstanding sports persons, cultural activities / N.S.S. of all categories who represented the Nation / State / University at the University / College / School level.

2. The Principal is authorized to admit the wife / son / daughter of Military personnel in active service whose family is residing in territorial jurisdiction of Nilamber-Pitamber University in addition to regular sanctioned number of seats.
3. The Principal is authorized to admit 3% of the total seats within the college physically handicapped students in U.G. class in addition to regular sanctioned number of seats.

## III Honours Courses

The following rules shall be followed in admission in B.A. / B.Sc. / B.Com three year Honours Degree course :-

1. The candidate seeking admission in Honours course must have obtained at least 45% marks in the subject concerned at the Intermediate / equivalent examinations.
2. The students passing Intermediate / equivalent examination in Science securing 45% in aggregate shall be eligible for admission either in Arts or Commerce Honours. Likewise students who have passed Intermediate with Arts or Commerce may be eligible for faculty change provided they had secured 45% marks in aggregate.

## IV Post-Graduate Courses

In addition to the general rule, the following rules / points must be followed at the time of admission in P.G. courses under Nilamber-Pitamber University


1. The students asking admission in Post-Graduate courses must have studied the receptive subject as Honours / a major subject at the under graduate level.
2. 10% of the total seats would be reserved for applicants who have passed from Nilamber-Pitamber University in B.A./B.Sc./B.Com. general

Students securing 1<sup>st</sup> division with at least 60% marks in the subject concerned under three years degree course scheme. A relaxation of marks up to 5% shall be given to the candidates belonging to ST, SC & OBC.

3. Such students who have secured honours major subject from other Indian Universities shall also be considered for admission as per criteria laid down in general rules provided Honours course passed is full Honours course of three years.
4. Provision for taking admission in subjects involving inter disciplinary nature are as under –
  - (a) Anthropology – Students graduated with Botany/ Zoology/ Chemistry may be admitted against 25% of the total seats and they shall be awarded with the degree of M.Sc. in Anthropology.
  - (b) Mathematics – Students graduated in the Faculty of Humanities and Social Sciences with Mathematics as Honours major subject shall be admitted and awarded with the degree of M.A. in Mathematics. Students graduated in the Faculties of Humanities/Social Science with Mathematics a subject in the General course may be considered under the 10% quota (as in the general rule) for the general course securing 60% marks in Mathematics.
5. The Vice-Chancellor shall have power to relax the above criteria and to increase the seats beyond the total number of seats upto 3% of the sanctioned seats for each category in cases of students who are :-
  - (i) Coming from foreign countries
  - (ii) Nominated by Govt. of India under various schemes
  - (iii) Coming under schemes of any State Govt. approved by the State of Jharkhand
  - (iv) Wife/son/daughter of military personnel in active service whose family may be residing in territorial jurisdiction of Nilamber-Pitamber University
  - (v) Physically handicapped
