- 4. Cancellation of Admission: The University reserves its right to cancel the admission of successful candidate under any of the following circumstances:
 - a) If the fee is not deposited by the stipulated date.
 - b) If the candidate does not join the particular programme by the stipulated date even though the fee has been deposited.
 - c) If the candidate fails to furnish the proof of the stipulated minimum qualifications.
- 5. The Competent Authority of the University reserves the right to alter or modify the structure of any of the programs to meet the objective of excellence.
- 6. The University reserves its right to change the existing fee structure without any prior information.
- 7. Payment by a student of any dues shall not establish a claim to admission or re-admission.
