 - a) If the fee is not deposited by the stipulated date.
 - b) If the candidate does not join the particular programme by the stipulated date even though the fee has been deposited.
 - c) If the candidate fails to furnish the proof of the stipulated minimum qualifications.
5. The Competent Authority of the University reserves the right to alter or modify the structure of any of the programs to meet the objective of excellence.
6. The University reserves its right to change the existing fee structure without any prior information.
7. Payment by a student of any dues shall not establish a claim to admission or re-admission.
