Advertisement for the Post of Director at Institute of Professional Studies

In the light of decision taken by the Academic Council in its 25th meeting held on 21.01.2026 and its subsequent approval by the Syndicate in its 96th meeting held on 22.01.2026, applications are invited in prescribed format for the post of Director, Institute of Professional Studies at Nilamber-Pitamber University. The University aims to bring all vocational education programmes under a unified institutional framework to promote academic coherence, interdisciplinary integration, and effective collaboration between industry and academia. This initiative seeks to establish vocational education as an integral and dynamic component of higher education, fully aligned with the objectives of the National Education Policy (NEP) 2020.

Key Responsibilities

- Coordinate and monitor all vocational courses offered by the University and its constituent colleges to ensure quality assurance and effective implementation.
- Develop and implement credit-based vocational frameworks, including internships, skill certification, and outcome-oriented curricula, in alignment with NEP-2020 objectives.
- Establish and maintain strategic linkages with industry partners, government bodies, and skill development agencies to foster collaboration and enhance employability outcomes.
- Oversee academic, administrative, and financial aspects of vocational education programmes in coordination with relevant University sections, ensuring transparency, accountability, and optimal resource utilization.

Eligibility Criteria

Retired academician of Nilamber–Pitamber University who have not attained the age of sixty-eight (68) years at the time of application.

Essential Experience

Minimum of thirty (30) years of teaching experience and at least five (5) years of administrative experience at the university/college level.

Appointment tenure

The engagement will be on a contractual basis initially for eleven (11) months, extendable on satisfactory performance, up to a maximum of three (3) years, but only for eleven (11) months at one time.

Honorarium

Consolidated honorarium of Rs. 60,000/- (Rupees sixty thousand) (fixed) per month.


